Food, nutrition and health

3 April to 7 June 2024

Research Awards Jesús Serra recognize the trajectory of young researchers working in Spain and support projects that represent significant advances with an impact on research in food, nutrition, and health.

Who can apply?

Young researchers working in Spain with important contributions to food, nutrition and health research. Applications can be submitted in two categories: **basic research and clinical research**.

When to apply?

Applications must be completed and submitted between **between April 3 and June 7 2024** at 14h CET (2024), both inclusive.

Fundación Occident

Fundación Occident is a private non-profit organization that was born within GCO (Grupo Catalana Occidente) in 1998, with the aim of channeling the sponsorship and patronage efforts that the insurance company had been developing for over a century. Its founder and promoter was Jesús Serra Santamans, who was also the founder of GCO and Occident.

Fundación Occident annually promotes a multitude of cultural, business, educational, musical, sports, social, and research initiatives.

The awards

The Research Awards Jesús Serra recognise a trajectory of research excellence that includes outstanding contributions to research in food, nutrition and health. **In the basic research category and in the clinical research category:**

Candidates can submit research work in:

- Clinical Nutrition
- Metabolism
- Epidemiology
- Genetics and Molecular Biology
- Food Science and Technology
- And, in general, biomedical research that intersects with nutrition.

If the research project accompanying the application is in the **pre-clinical phase**, the category should reflect the long-term objectives of this line of research.

Evaluation criteria

The criteria that will be evaluated in the selection process are:

1. Education

The prize winner should have an excellent academic background and/or professional experience. Researchers who have received academic recognition, or those who have spent time abroad, will be highly valued.

2. Innovative characteristics

The candidates must detail the distinctive and innovative contributions made throughout their career, whether from a conceptual, methodological, or technical perspective.

3. Impact of research

The candidate's number of publications and their scope will be taken into account. Research invited talks as well as leadership or important contributions to research projects will also be considered research merits.

4. Social benefits

The jury will assess the contribution of their research to the creation of a high added-value to society. That is, the field of research should address a relevant societal problem with a direct link between food, nutrition and health.

5. Scope of research

Key elements of the project and the scientific trajectory will also be valued, such as international projection or the potential to transfer the knowledge generated to other disciplines.

6. Use of the financial endowment

The financial endowment of the award must be dedicated to the research activity led by the awardees. Any expenditure necessary for the implementation of the project submitted, including personnel, goods and services, subcontracting costs and equipment, may be covered with the prize money. Indirect costs are not covered.

Candidate Profile

Candidates must meet each and every one of the following requirements:

- Have not turned 46 years old by the closing day of this call, 7 June 2024.*
- Be a Spanish and/or foreign researcher with a minimum of 3 years of research in Spain.
- Having made outstanding contributions to research in food, nutrition, and health, and belonging to a research centre or Spanish university of recognised prestige.
- Having the endorsement of their project supervisors or professionals linked to universities, hospitals or research centres and networks in Spain.

* The researcher's age may exceed 46 if the candidate has temporarily interrupted his or her career as a result of the birth or adoption of children and their care during the first months of life. Proof of these extended months must be provided with the relevant official documentation.

The jury

The jury responsible for selecting the winners is composed of **six members with recognised prestige in the field of medicine and health research from national and international centres of excellence**. The jury expands each year with the two winners from the previous edition. There will also be one representative from Fundación Occident acting as secretary, without the right to vote. As such, the jury is made up of a total of nine members.

The jury's decision:

Simple majority: The final decision on the candidate to be awarded in each category will be made by simple majority has been reached. The decision is final and must be sufficiently reasoned.

Conflict of interest: Members of the jury cannot endorse candidates. In the event of any conflict of interest, the jury member in question must abstain from the vote.

In-person and non-delegable vote: Jury members' votes must be made in person at the time of the vote, and are non-delegable.

Unawarded prizes: In the event that none of the candidates under consideration meet the requirements or objectives of the awards, the jury reserves the right not to award any prizes.

Interpretation of the rules of submission: The jury has the authority to resolve, together with the Management of Fundación Occident, any other question regarding the interpretation of the rules of submission which may arise.

Resolution: The jury's decision will be announced on the website fundacionoccident.org/eng/awards-research and at the Awards Ceremony in November 2024.

Submission of applications

Each proposal must consist of:

1. Application form

Completion and presentation of applications can be done in Spanish or English, and must be submitted through the website fundacionoccident.org/eng/awards-research.

2. Supporting letter

All applications must be endorsed by at least one letter of support from the head of research or a relevant person linked to a university, hospital, research centre or networks.

3. Candidate's CV

All applications must be accompanied by the candidate's abbreviated CV in PDF format including the impact factor and the position of the candidate in each role, as well as their role and contribution to the projects in which they have participated.

4. Research project

All applications must be accompanied by a relevant research project, either in progress or currently being financed, with relevant participation of the candidate.

Candidates who have not won in previous editions may re-submit their application. If they wish to retrieve information previously submitted in electronic forms, they may contact the Awards secretary via the email: investigacion@fundacionoccident.com.

Candidates will guarantee, with total indemnity for Fundación Occident, the veracity of information provided, as well as the authorship, ownership and exploitation rights vis-a-vis third parties of all graphic materials, trade names and other information included in the documents on which the application is based. The application must not have been submitted in parallel to any other competition for which the result is yet to be announced.

The Awards organisation undertakes to maintain the confidentiality of all data and not to disclose the identity of the candidates until the jury makes its decision.

Awards ceremony

Awards ceremony

The awards ceremony will take place in Madrid on November 20, 2024. The prize winners are required to attend this event.

Prize

The prize for these awards will be €50,000 for each category: basic and clinical. The amount must be allocated to activities related to the presented research project.

Payments will be split into two installments. The first installment, which represents 50% of the total prize amount, will be disbursed after the award ceremony. The second installment, the remaining 50% of the prize, will be disbursed 12 months after the ceremony and after the winners have submitted a progress report on their research.

Specific conditions

Attendance of the awards ceremony is mandatory. In case of overwhelming force, the winner will have to appoint a delegate to attend the ceremony.

The winners agree to participate in activities organised by Fundación Occident, such as debates, talks and meetings. Fundación Occident may request the winners to produce a brief annual report on their career progress during the two years following the award. In this case, the report should be sent to Fundación Occident via the email address: investigacion@fundacionoccident.com.

Use of information

Information included in the form and personal data:

- Fundación Occident will be able to publicise the winning projects in the way it considers most appropriate for its dissemination.
- As such, participants expressly accept and authorise that the data of the resolution (name of the winner, institution and summary of the candidacy) as well as any images and/or sound recorded during the awards ceremony may be disseminated via any medium, publicity or media, including the website of Fundación Occident and GCO as well as their profiles on social media, in order to inform and publicise the Awards.
- Participants expressly disclaim any type of compensation, either financial or of any other nature, for the recording and use of their image and/or voice in the context of the Research Awards Jesús Serra.

Data Protection

Information included in the form and personal data:

- The personal data provided in order to participate in the Awards will be stored in a file owned by the organisation, under the responsibility of Fundación Occident, whose purpose is to manage the awards and its publicity. In addition, this data may be transferred, for identical purposes, to the entities that make up GCO (identified on the website occident.com).
